

TERMS AND CONDITIONS OF REDDITCH GOLF CLUB'S "CHOICES" MEMBERSHIP

- The Business & Finance Committee reserve the right to amend pricing of new Choices subscriptions at any time. 2018 Choices subscription is £520.00 per annum (450 credits). Choices Lite is £205.00 per year (150 credits).
- Membership is deemed to be annual starting from the month of joining/renewal.
- "Choices Lite" category is only available to existing members or previous members.
- The England Golf and Worcestershire County Golf Union affiliation fee is included in the annual fee.
- Unused credits can be carried over at the year-end upon subsequent renewal. However, if membership is not continued any credit balance will be forfeited.
- Credits are strictly non-transferable to other Choices members.
- Credits can only be used for member's own golf and cannot be spent on Pro Shop purchases, Buggy Hire or competition entry fees.
- Only **ONE** £100.00 top up per annum of 100 credits will be allowed which can be purchased from the Office. After this, you can either buy a new Choices membership package or move across to a 5, 6 or 7-day full playing membership. This new membership will be applicable for 12 months from the changeover date.
- Choices Members **MUST** present their swipe card in the Pro Shop or Bar, **BEFORE** play, so that credits can be deducted. Any transgression of this condition can result in the immediate termination of membership and the loss of all outstanding credits. The Club's software keeps a real-time record of credits used.
- Choices Members **MUST** display their membership bag tag at all times as random inspections will take place on and around the course.
- Choices Members are welcome to invite guests to play with them. Invitee restrictions will be as per the Club's Bye laws. Choices members **CANNOT** play as a guest of another RGC member.
- Worcestershire County Golf Union County cards will be issued which provide discounted green fees at most golf clubs throughout the country.
- Choices Members may gain and maintain an official CONGU handicap.
- Choices Members can only play in non-trophy club competitions, (on payment of the appropriate number of credits and competition entry fee). A full list of competitions attached.
- Choices Members may not play in the Club teams.
- Choices Members are not Voting Members of the Club.
- Choices Members may **NOT** participate in any reciprocal deals organised by the Club for Full playing members.
- Choices Members are **NOT** included in the Club's Public Liability Insurance Scheme.
- Choices Members may **NOT** play prior to **8am** on any day.
- The full amount of credits due will be payable even if the full 18 holes are not completed.
- The Business & Finance Committee reserves the right to amend these terms and conditions at any time.
- You are no longer entitled to, or have priority over, your assigned locker. If requested, you will be required to hand back your locker key to the General Manager within 30 days of the request.
